1 Introduction

1.1 This is one of a series of Background Papers accompanying the Replacement Local Development Plan (RLDP). When the Council publishes its Deposit Plan, it must also explain how the policy has been formulated based on the evidence base available to the Council at the time.

1.2 This paper has been prepared jointly with CCBC Education Services. A Statement of Common Ground has been prepared alongside this paper. The purpose of this background paper is to:

- Detail RLDP population change and the potential impact on pupil numbers.
- Detail current school provision and the Sustainable Communities for Learning Programme.
- Identify if strategic land allocations and safeguarded areas to meet new school provision are required.
- Assess the impact of the proposed residential allocations and other housing sites on school capacity and recommend appropriate mitigation.
- Review the current adopted LDP education policy and provide an overview of the amended policy approach for the RLDP.

2 National planning policy and guidance

2.1 Planning Policy Wales (PPW) has been revised in order to bring it in line with the Well-being of Future Generations (Wales) Act 2015. PPW is split into four distinct themes, which bring the requirements of the Act into context for planning policy and show the inter-linkages between planning policies. Education falls in the Active and Social Places theme, under Community Facilities.

- 2.2 Para 4.4.1 states schools, and other community facilities, contribute towards a sense of place, which is important for health, well-being and amenity of local communities. Community facilities, such as schools, are often a key element of viable and sustainable places.
- 2.3 Local planning authorities should develop a strategic and long-term approach to the provision of community facilities, including schools. The needs of the local community should be taken into account when considering development proposals, to ensure that the provision continues to meet the requirements of local residents.
- 2.4 Schools are also included in the Strategic Placemaking Section of PPW, under accessibility. Major generators of travel demand, including schools, should be located in the existing urban areas or areas which are easily reached by walking or cycling, and served by public transport.
- 2.5 Sensitive uses, including schools, should not be located adjacent to busy roads or other transport routes where there are no connectivity benefits, and where the increased exposure to pollutants impacts health and amenity negatively (para 6.7.19). Mitigation and good design may be able to overcome the negative impact on health and well-being.

3 Current school provision

- 3.1 There are 51 primary schools, 7 secondary schools, 1 Special School and 4 Pupil Referral Education Centres in Conwy County Borough. Independent school education is also available in the County Borough at St David's College and Rydal Penrhos. Not all pupils will be Conwy County Borough residents.
- 3.2 Local Authorities have a statutory duty (School Standards and Organisation Act Wales (2013)) to prepare and submit the Welsh in Education Strategic Plan to the Welsh Government. These plans will run for a period of 10 years from September 2022 and outline how Local Authorities intend to achieve the Welsh Government's aims and targets set out in the Welsh-medium Education Strategy.

3.3 Conwy's Welsh in Education Strategic Plan has a target to increase Welsh-medium provision in the County Borough by 14% + over the next ten years in order to reach the Welsh Government's goal of 30% by 2031.

3.4 There are the following Welsh language schools in Conwy County Borough:

- 20 Welsh medium schools, where Welsh is the day to day language of the school;
- one dual stream school, where Welsh and English are used as the day to day language of the school;
- and one bilingual school, where 50-79% of the subjects are taught through both English and Welsh; and
- 14 English schools with significant Welsh, where the day to day language or languages of the school are determined by the school's linguistic context.

3.5 There are five faith schools in the County Borough:

- St Josephs, a Catholic primary school in Colwyn Bay;
- Y Plas, a Church in Wales primary school in Llanellian;
- Ysgol San Sior, a voluntary aided Church in Wales primary school in Llandudno;
- Ysgol Bodafon, a Church in Wales primary school in Llandudno; and,
- Ysgol Blessed William Davies, a Catholic primary school in Llandudno.

4 Sustainable communities for learning programme

4.1 Welsh Government has a new programme for long-term investment in schools and colleges to develop them as hubs for learning and reduce buildings in poor condition.

4.2 Close working takes place between CCBC Education and the Strategic Planning Policy Service to support the delivery of these projects. For the RLDP, this includes provision for land for new schools or extensions to

existing (where required) and a policy approach to guide applications. See Section 6 for more details.

- 4.3 The first wave was delivered as Band A as part of the 21st Century Schools and Education programme and was completed in March 2019. Band A in Conwy County Borough delivered changes in four areas. A new dual stream primary school, Ysgol Awel y Mynydd, was built in Llandudno Junction, which brought pupils from Ysgol Maelgwn and Ysgol Nant y Coed together. The school was officially opened in November 2017.
- 4.4 A new all through primary school, Ysgol Nant y Groes has been built in Colwyn Bay, through refurbishment and extension on the existing school site. It brought pupils from Ysgol Glan y Mor Infant School and Ysgol Pendorlan Junior School together. The new school opened in January 2018.
- 4.5 The former Ysgol Tan y Marian site was redeveloped to bring pupils from Ysgol Babanod Penmaenrhos and Ysgol Iau Tan y Marian together in a newly established Ysgol Swyn y Don. This is an all through primary school, which opened in January 2018.
- 4.6 A new school, Ysgol Dyffryn yr Enfys, was built in Dolgarrog, which replaces Ysgol Dolgarrog, Ysgol Tal y Bont and Ysgol Trefriw. The school opened in 2019.
- 4.7 The approach has since changed to reflect the findings of previous experience. It is now a rolling 9 year programme, with regular reviews. This is due to be presented to CCBC Cabinet on 16th July 2024. This section of the paper will then be updated.
- 4.8 The report suggests the following projects (subject to political endorsement):
- **Years 1-3: Ysgol y Gogarth and Ysgol Eirias**
No additional land is required for these projects. The RLDP policy approach will support any planning applications, subject to other policy requirements.
 - **Years 4-6: Ysgol Deganwy and the Llanfairfechan area**

Ysgol Deganwy is currently over capacity and has a temporary classroom on site. Increasing capacity at the current school site through an extension could resolve these issues. Should a new school be considered necessary in future, the RLDP policy approach will support this, subject to other policy requirements.

The existing school sites in Llanfairfechan are constrained and options to extend current buildings are limited. Land was allocated to support a new school on the Strategic Site allocation at Preferred Strategy stage of the RLDP process. This land will continue to be allocated through the RLDP process.

- **Years 7-9: area review of Llandudno schools**

Close working with SPSS and Education will continue to take place to support this review. The proposed RLDP policy approach will support any refurbishment/extensions at existing sites, or new school sites depending on the outcome of the review.

5 Impact of projected growth during RLDP period on school capacity

5.1 Growth option 4 is the option progressed in the Deposit RLDP. Please see Background Paper 1 for more details. The table below shows a general summary of the impact across the County Borough on school age children.

- 5.2 It predicts that there will be a significant decline in primary pupil numbers (850 fewer age 5-10 year olds), and an increase in secondary pupil numbers. Unfortunately, the accuracy of these projections at a smaller geography means that it would not be appropriate to split these figures into a smaller geographic area, as they cannot take the spatial distribution of new housing and changes at the individual settlement level into account.
- 5.3 For this reason, a review of school provision in each settlement was conducted. The starting point was to review current school capacity, pupil numbers and projected pupil numbers from the Pupil Level Annual Schools Census (PLASC) data. Five year projections for each school based on pupils who already attend and younger children who live in the catchment areas are produced.
- 5.4 These use a different methodology to the projections used in Background Paper 1: Growth Level Options Report. The PLASC projections are more appropriate to use at a small area (school) level than those in Background Paper 1, but do have their drawbacks. They do not make an allowance for in/out migration or for parental choice. Regular monitoring is therefore required to make sure the data used remains robust and relevant.
- 5.5 Detailed analysis was conducted to show how many pupils in each school live in the catchment area. This was to assess whether capacity could be created through applying the school catchment policy more rigidly.
- 5.6 The school projections do not take migration into consideration. For this reason, an estimated number of pupils resident in new dwellings, which have been granted permission and RLDP allocations in each school area has been included. The estimate is based on the average household occupancy of children that age from the 2021 Census.

- 5.7 The final step was to analyse where pupils living in each catchment area go to school. This helps to inform where the pupils living in new developments are likely to go to school. Faith, language and parental choice is considered in this assessment.
- 5.8 Another factor to note is that a proportion of the residents of the new dwellings will already be living in the County Borough. Pupils may, therefore, be attending a school locally, however, they may also change to attend the closest school to their new home. There is not data available to assess this in an accurate way, and so it has not been factored in to the impact assessment below.

6 RLDP policy approach

- 6.1 The adopted LDP includes policy CFS/15 which supports proposals for new schools, subject to the development principles policies. The policy has been applied successfully to assist with proposals for new schools granted planning permission during the plan period, it offers little guidance in two areas. Firstly for extensions to existing schools, which can be large scale. Secondly, there is no guidance for what would be considered an appropriate location for a new school.
- 6.2 The RLDP can allocate and safeguard land where necessary for new schools or extensions to existing ones. There will be a criteria based policy which guides the location of new school sites, permitting them adjacent to settlement boundaries where no appropriate location inside can be found.
- 6.3 Where major residential developments (whether on allocated or windfall sites) are likely to cause or exacerbate school capacity issues, financial contributions will be sought to help address these matters. Financial contributions towards schools will be collected in the form of a S106 planning obligation. In order for a planning permission to be granted, the S106 will need to be signed. National legislation places restrictions on the pooling of financial contributions from planning, where we can only seek the same obligation 5 times. In locations with significant school capacity issues, this must be

considered at an early stage in discussion with CCBC Education to ensure that S106 contributions are collected lawfully.

6.4 The financial contribution requested would need to be evidenced appropriately to meet the CIL Regulations and other planning requirements. Regulation 122 (2) states that an obligation sought must be:

- I. Necessary to make the development acceptable in planning terms;
- II. Directly related to the development; and
- III. Fairly and reasonably related in scale and kind to the development.

6.5 For seeking an obligation towards education provision, it must be demonstrated that there is a capacity issue due to the physical infrastructure (not staffing) and a funding gap that no other sources can cover.

6.6 The amount to be sought will be calculated based on the estimated pupil numbers and construction costs, which will be set out in Supplementary Planning Guidance to accompany the RLDP. Any obligation sought will need to relate to the proposed development in terms of estimated new pupil numbers, and cannot be used to remedy an existing shortfall in capacity.

7 Primary schools

7.1 West RLDP strategy area: Llanfairfechan, Penmaenmawr and Dwygyfylchi

7.1.1 Primary school provision in Llanfairfechan is currently covered by two schools, Ysgol Pant y Rhedyn (128 pupils) and Llanfairfechan Infants (87 pupils). Pupil numbers are projected to decrease over the next 5 years for both schools.

7.1.2 Ysgol Pencae in Penmaenmawr (123 pupils) provides Welsh language education for the strategy area. There is some capacity at Ysgol Pencae, with pupil numbers projected to increase over 5 years.

7.1.3 Primary school provision in Dwygyfylchi is covered mainly by Ysgol Capelulo (135 pupils). Penmaenmawr is also in its catchment area. The school is currently almost at capacity, with pupil numbers projected to increase.

7.1.4 The table above also shows the proportion of current pupils who attend the schools that live within the official school catchment area for each school. For all schools in this area, the majority attending are from inside the school catchment area.

7.1.5 Not all children living in new developments proposed or committed in the area will attend their local catchment schools. Some will choose an out of catchment school for various reasons. Some will choose Welsh medium or faith schools.

7.1.6 The table below shows the school choice of pupils who live in the school catchment area for Llanfairfechan infants and Ysgol Pant y Rhedyn. It does not include any pupils accessing education in Gwynedd. The majority of pupils accessing Welsh language education were attending Ysgol Pencae in Penmaenmawr. Included in the other category is a very small number who attend Ysgol Gogarth.

7.1.7 The table below shows the school choice of pupils who live in the school catchment area for Ysgol Pencae in Penmaenmawr. The catchment covers all of the West area. 21% of children in this area access Welsh language education. 70% access local English medium schools. Included in the other category is a very small number who attend Ysgol Gogarth.

8.1.8 The table below shows the school choice of pupils who live in the school catchment area for Ysgol Capelulo. Almost half of the children attended Ysgol Capelulo. 37% went to Penmaenmawr for Welsh medium education. A very small number who attend Ysgol Gogarth are included in the other category.

7.1.9 The table below shows the estimated number of pupils that could be resident at sites in the school catchment areas with planning permission granted. It is important to note that many of these pupils will already be resident in Conwy County Borough and not all will attend their local catchment school (see school choice tables above). The Strategic Site allocation at Llanfairfechan provides the majority of future residential development in this area.

Recommendations

7.1.10 Capacity will be monitored through the RLDP process for all schools. A financial contribution will be sought from developments (subject to financial viability), should capacity indicate it is necessary.

7.1.11 Llanfairfechan Infants and Ysgol Pant y Rhedyn: CCBC Education

Services are proposing a new school, amalgamating primary provision in Llanfairfechan as part of the Sustainable Communities for Learning Programme for the County Borough. Land will be allocated on part of the RLDP Llanfairfechan strategic site to accommodate this (subject to Cabinet decision 16/07/2024). Discussions with the developer and landowner are ongoing.

7.1.12A financial contribution will be required from sites in the area, dependent on school capacity at the time (and subject to viability).

7.1.13 **Ysgol Pencae:** there is currently anticipated to be sufficient capacity at this school to meet the Welsh language needs of the area. Should pupil numbers increase significantly, a financial contribution will be required from sites across the West area (subject to viability).

7.1.14 **Ysgol Capelulo:** this school is currently at capacity and projections are showing this will continue. The school offers English medium education for both Penmaenmawr and Dwygyfylchi. Based on these figures, a financial contribution will be required from sites in this area (subject to viability).

7.2 Creuddyn RLDP strategy area

7.2.1 Primary school provision in Llanrhos and Deganwy is currently covered by Ysgol Deganwy (298 pupils). There is some capacity available. Pupil numbers are projected to remain stable over the next 5 year period.

7.2.2 Ysgol Awel y Mynydd in Llandudno Junction is a dual stream primary school. The English stream catchment is for Llandudno Junction only. The Welsh stream catchment covers a larger area, including Deganwy, Conwy and Glan Conwy. It has a capacity of 460 pupils. 361 pupils currently attend, which leaves 98 unfilled spaces.

7.2.3 Ysgol Porth y Felin is the primary school serving Conwy. It has a capacity of 325 pupils. 310 pupils currently attend, which leaves 15 unfilled spaces. Ysgol Llangelynnin is also relevant for Welsh medium education here. There are currently 34 unfilled places here, with school numbers projected to remain steady.

7.2.4 Ysgol Glan Conwy has a capacity of 145 pupils. 115 pupils currently attend, which leaves 30 unfilled spaces. A small increase in pupil numbers is projected.

7.2.5 Ysgol Glanwydden is the primary school serving Penrhyn Bay. It has a capacity of 287 pupils. 276 pupils currently attend, which leaves 11 unfilled spaces. Ysgol Morfa Rhianedd in Llandudno provides Welsh medium education for this area.

- 7.2.6 Primary school provision in Llandudno is provided by Ysgol Tudno (161 pupils), Ysgol Ffordd Dyffryn (153 pupils), Ysgol Craig y Don (274 pupils) for English medium education and Ysgol Morfa Rhianedd (134 pupils) providing Welsh medium education. Ysgol San Sior (212 pupils), Ysgol Bodafon (80 pupils) and Ysgol Blessed William Davies (116 pupils) provide faith education.
- 7.2.7 There is some capacity at all schools except for Ysgol San Sior. Projections show pupil numbers decreasing across most schools. Ysgol Morfa Rhiannedd and Ysgol Blessed William Davies are predicted to have stable pupil numbers.

- 7.2.8 The table above also shows the proportion of current pupils who attend the schools that live within the official school catchment area for each school. For

Ysgol Deganwy, a significant proportion attend from outside of the school catchment area. The majority of these live just outside the catchment boundary in Llandudno Junction.

7.2.9 The Ysgol Awel y Mynydd figures are for the catchment for the English stream. The out of catchment pupil number includes those who live in the Welsh stream catchment (45 pupils or 11%), and so depending on which stream the pupils attend, the proportion could be higher from within the catchment.

7.2.10 Nearly two thirds (64%) of pupils attending Ysgol Porth y Felin are from within its catchment area. 15% attend from Llandudno Junction.

7.2.11 A large proportion (80%) of Ysgol Glan Conwy are from within the catchment area. For Ysgol Glanwydden, almost half of pupils attend from outside of the school catchment (45%). The majority are from neighbouring areas.

7.2.12 For Llandudno schools, although the percentage pupils attending outside of the school catchment is high for some, the majority are from the local area of Llandudno.

7.2.13 Not all children living in new developments proposed or committed in the area will attend their local catchment schools. Some will choose an out of catchment school for various reasons. Some will choose Welsh medium or faith schools.

7.2.14 The table below shows the school choice of pupils who live in the Ysgol Deganwy catchment area. Almost two thirds (65%) choose Ysgol Deganwy. There was also a very small number who attend Ysgol Gogarth.

7.2.22 Capacity will be monitored through the RLDP process for all schools. A financial contribution will be sought from developments (subject to financial viability), should capacity indicate it is necessary.

7.2.23 **Ysgol Deganwy:** land was allocated for education as part of the strategic site allocation at Llanrhos for Preferred Strategy stage of the RLDP. Due to changes to the site size and number of new homes, it is now considered that the additional capacity required can be accommodated on the existing school site. Should it be considered that a new school is required, the RLDP policy framework for new schools will support this on land outside the settlement boundary, subject to other policies. A commuted sum will be required from the Strategic Site allocation and other sites within the catchment area should there be a capacity issue in future (subject to viability).

- 7.2.28 **Ysgol Morfa Rhianedd:** Current school capacity is currently considered sufficient to accommodate any increase in pupils attending the school and accommodate Welsh medium education for the area.

7.3 Central RLDP strategy area: Rhos on Sea, Colwyn Bay, Old Colwyn, Mochdre and Llysfaen

- 7.3.1 Primary school provision in Rhos on Sea is currently covered mainly by Ysgol Llandrillo yn Rhos (400 pupils). There is some capacity available at the school currently. Pupil projections are estimating a decrease.
- 7.3.2 Primary school provision in Colwyn Bay is currently covered mainly by Ysgol Pen y Bryn (398 pupils), Ysgol Nant y Groes (223 pupils) and Ysgol Bod Alaw (280 pupils), which offers Welsh medium education for the strategy area. Ysgol St Joseph (208 pupils) and Ysgol y Plas (69 pupils) offering faith options are also relevant. There is some capacity available at Ysgol Pen y Bryn, Ysgol Nant y Groes and Ysgol Bod Alaw. Ysgol St Joseph is currently at capacity.
- 7.3.3 Primary school provision in Old Colwyn is currently covered mainly by Ysgol Swyn y Don (116 pupils), Ysgol Hen Golwyn (205 pupils) and Ysgol T Gwynn Jones (149 pupils). There is some capacity available at all three schools, but only 13 spaces at Ysgol Hen Golwyn.
- 7.3.4 Primary school provision in Mochdre is covered mainly by Ysgol Cystennin providing education for junior age children and Mochdre infants (108 pupils for both schools). There is some capacity available at Ysgol Cystennin and Mochdre infants. CCBC Cabinet has approved the amalgamation of these two schools in January 2024. The analysis in this chapter has been combined on this basis.
- 7.3.5 Primary school provision in Llysfaen is currently covered by Ysgol Cynfran (159 pupils). There is capacity available at Ysgol Cynfran.

Ysgol Nant y Groes by comparison has a higher proportion of pupils living within its catchment area. For Ysgol Bod Alaw, the majority live within the catchment, which covers a large area as the Welsh medium provider for this area.

- 7.3.8 Almost three quarters of pupils attending school in Mochdre live inside the catchment area of both schools. Pupils attending from outside of the catchment live mostly in the neighbouring areas.
- 7.3.9 A high proportion (88%) of pupils attending Ysgol Swyn y Don live inside the catchment area. Around half of pupils attending Ysgol T Gwynn Jones or Ysgol Hen Golwyn live inside the catchments. The majority of pupils live in Old Colwyn.

Should the school reach capacity, a financial contribution will be required from sites in the catchment area (subject to viability).
- 7.3.28 **Ysgol T Gwynn Jones and Ysgol Iau Hen Golwyn:** there is currently some capacity in the school and pupil numbers are projected to fall slightly. Although the large strategic site allocation falls outside of the catchment area

for these two schools, they are a school of choice for current pupils in the area. Should pupil numbers increase, a financial contribution will be required from sites in the catchment area (subject to viability).

7.4.1 Primary school provision in Abergele is currently covered mainly by Ysgol Babanod Glan Gele (215 pupils) and Ysgol Iau Sant Elfod (288 pupils) for English medium education. Ysgol Glan Morfa (225 pupils) provides Welsh medium education for the East area. There is some capacity at all three schools currently. Ysgol Glan Gele and Ysgol Sant Elfod are projected to have a small fall in pupil numbers. Ysgol Glan Morfa is projected to have a small increase.

7.4.2 Ysgol St George (62 pupils) is also relevant to the East area. The catchment of this school is small and covers part of the Gele ward that falls outside of the settlement boundary of Abergele.

7.4.3 Primary school provision in Towyn and Kinmel Bay is currently covered mainly by Ysgol y Foryd (165 pupils) and Ysgol Maes Owen (208 pupils). Welsh medium education is provided by Ysgol Glan Morfa in Abergele. Both schools have capacity and pupil numbers are projected to decrease.

7.4.4 Primary school provision in Llanddulas is currently covered mainly by Ysgol Llanddulas (131 pupils). The school is currently at capacity. Pupil numbers are projected to fall.

- 7.4.5 The table above also shows the proportion of current pupils who attend the schools that live within the official school catchment area for each school.
- 7.4.6 The majority of pupils attending Ysgol Glan Gele, Ysgol Sant Elfod, Ysgol Glan Morfa, Ysgol y Foryd and Ysgol Maes Owen are from within the school catchment areas. For Ysgol St George, a very small amount attend from within the catchment area. Around half of pupils at Ysgol Llanddulas live within the catchment.
- 7.4.7 Not all children living in new developments proposed or committed in the area will attend their local catchment schools. Some will choose an out of catchment school for various reasons. Some will choose Welsh medium or faith schools. For pupils living in Abergele, the majority attend one of the three schools there.

7.4.9 No further analysis of school choice in Towyn and Kinmel Bay and St George have been considered necessary, as it is highly unlikely that there will be significant residential development in these areas.

7.4.10 The table below shows the estimated number of pupils that could be resident at sites in the school catchment areas with planning permission granted. It is important to note that many of these pupils will already be resident in Conwy County Borough and not all will attend their local catchment school (see school choice tables above). No allocations are proposed through the RLDP for the East area, as it is considered that existing commitments and windfall sites will deliver the housing need over the Plan period.

Recommendations

- 7.4.1 Capacity will be monitored through the RLDP process for all schools. A financial contribution will be sought from developments (subject to financial viability), should capacity indicate it is necessary.
- 7.4.2 **Ysgol Glan Gele and Ysgol Sant Elfod:** A financial contribution will be required from sites in the area, dependent on school capacity at the time (subject to viability).
- 7.4.3 **Ysgol Glan Morfa:** A financial contribution will be required from sites in the area, dependent on school capacity at the time (subject to viability).
- 7.4.4 **Ysgol y Foryd and Ysgol Maes Owen:** National planning policy currently restricts the level of house building that is permitted in Towyn and Kinmel Bay. For this reason, no large developments are proposed as part of the RLDP. It is highly unlikely that the RLDP will lead to an increase in school pupil numbers, there is sufficient capacity in the current school provision, and pupil projections show a decrease in the number of pupils.
- 7.4.5 **Ysgol St George:** National and local planning policy restrict the level of house building that is permitted in the Ysgol St George catchment area. For this reason, no large developments are proposed in this area as part of the RLDP and therefore, no obligations can be sought.
- 7.4.6 **Ysgol Llanddulas:** A financial contribution will be required from windfall sites in the area, dependent on school capacity at the time (subject to viability).
- 7.5 Rural RLDP area: Llanrwst**
- 7.5.1 Primary school provision in Llanrwst is currently covered mainly by Ysgol Bro Gwydir (294 pupils). The school currently has a small amount of capacity. Ysgol Llanddaged (36 pupils) is also relevant, and also has capacity.

7.5.2 The table above also shows the proportion of current pupils who attend the schools that live within the official school catchment area for each school. The majority of pupils (80%) attending Ysgol Bro Gwydir live inside the catchment area.

7.5.3 Not all children living in new developments proposed or committed in the area will attend their local catchment schools. Some will choose an out of catchment school for various reasons. Some will choose Welsh medium or faith schools. The table below shows the school choice of pupils who live in Ysgol Bro Gwydir catchment. A large proportion (89%) choose their local school.

7.5.4 The table below shows the estimated number of pupils that could be resident at sites in the school catchment areas with planning permission granted. It is important to note that many of these pupils will already be resident in Conwy County Borough and not all will attend their local catchment school (see school choice table above). The Llanrwst Strategic Site allocation is expected to meet the majority of remaining housing need for Llanrwst. The current adopted LDP allocation at Llanrwst is also relevant. The windfall figure is for sites across the whole rural area, which are likely to be small in size.

Recommendations

7.5.5 Capacity will be monitored through the RLDP process for all schools. A financial contribution will be sought from developments (subject to financial viability), should capacity indicate it is necessary.

7.5.6 **Ysgol Bro Gwydir:** there is currently anticipated to be sufficient capacity at the school to meet the education needs of the area. Should pupil numbers increase significantly, a financial contribution may be required from sites in the catchment area (subject to viability).

7.5.7 Other schools in the Rural strategy area have not been included as it is unlikely that any residential development will meet the site threshold of 10 dwellings needed before an obligation towards schools is sought.

8 Secondary schools

8.1 Unlike for primary pupils, the population projections for the RLDP show an increase of 400 residents in the 11-17 age group. This has been split by RLDP growth strategy area below.

8.2 Although there are soundness concerns over using these projections at a smaller area, it does help indicate where growth could occur. PLASC data projections are included in the table below, which provide a second indicator of change for each of the secondary schools in the County Borough.

8.3 The table below shows current and projected pupil numbers compared with capacity. Most secondary schools have sufficient capacity to accommodate the projected pupil increase. There may be a capacity issue at Bryn Elian in the future. The catchment area for this school covers Betws yn Rhos, Eirias

and Colwyn wards, Llysfaen and Llanddulas. 63% (585 pupils) live in these areas. 36% (335 pupils) live outside of the catchment area.

- 8.4 Ysgol Creuddyn is currently under capacity with some space, however, pupil projections are estimating a significant increase.

Recommendations

- 8.5 It is anticipated that the current school provision will be able to accommodate the growth in this age group during the RLDP period for English medium education. Capacity will be monitored for all schools through the RLDP process.
- 8.6 **Ysgol Bryn Elian:** Safeguarding land adjacent to the Ysgol Bryn Elian site was considered due to capacity constraints there. Due to uncertainty over potential funding of any extensions, however, it is considered that deliverability of any scheme cannot be demonstrated to justify this. In addition, the land is outside of the settlement boundary, where development is not normally permitted. The new RLDP schools policy approach supports an extension to the school on this land, subject to other policy requirements. A financial contribution may be required from sites, dependent on school capacity at the time (subject to viability).

- 8.7 **Ysgol Creuddyn:** additional capacity may be needed here in future, if pupil numbers continue to increase. The new RLDP schools policy approach supports an extension to the school on this land, subject to other policy requirements. A pro rata contribution reflecting an estimated number choosing Welsh language education will be sought (subject to viability).

9 Additional learning need provision

- 9.1 An extension to Ysgol Gogarth is proposed as part of the Sustainable Communities for Learning Programme for delivery in years 1-3. It is anticipated that this will meet the short term needs of the school. Further monitoring will be required through the RLDP process.
- 9.2 It is anticipated that there will be sufficient capacity at the Pupil Referral Units to accommodate the growth options proposed in the RLDP. This will be monitored through the RLDP process.

10 Conclusion

- 10.1 This paper sets out the Council's approach for mitigating for the impact of the predicated population change over the RLDP period on schools in the plan area. It is aligned with the Sustainable Communities for Learning Programme. The paper and proposed approach was prepared jointly by the CCBC Strategic Planning Policy Service and Education Services, who support the approach proposed, as shown in the accompanying Statement of Common Ground. This close working will continue through the RLDP period to monitor capacity and other school needs, so that appropriate mitigation can be sought as required.
- 10.2 The RLDP proposes to allocated land for a new school at Llanfairfechan, on the Strategic Site allocation. It also proposed to safeguard land adjacent to Ysgol Swyn y Don to accommodate an extension, should this be required in future. Financial contributions will be sought where evidence shows that it is required to mitigate the impact of any proposed residential development.

10.3 The proposed RLDP policy approach for schools will include a criteria based approach to guide proposals for new schools and extensions to existing ones.
