Ar 18 Chwefror 2022 bu i Gyngor Bwrdeistref Sirol Conwy wneud y Gorchymyn a enwir uchod o dan Adrannau 1 a 2 o Ddeddf Rheoli Traffig Ffyrdd 1984, y bydd ei effaith yn gwahardd cerbydau rhag aros ar unrhyw adeg ar y darnau o ffordd a nodir yn Atodlen 1 ac i dynodi'r darn o ffordd a nodir yn Atodlen 2 yn fae parcio anabl.

Mae eithriadau yn y Gorchymyn i ganiatáu aros at ddibenion gollwng, casglu, llwytho a dadlwytho a gwneud gwaith cynnal a chadw, trwsio ac ati. Caiff eithriadau eu cynnwys yn y Gorchymyn ar gyfer cerbydau sy'n arddangos Bathodyn Person Anabl yn ogystal â Disg Parcio Person Anabl. Gellir archwilio copi o'r Gorchymyn a'r cynllun, a fydd yn dod i rym ar 1 Mawrth 2022 ar wefan y Cyngor.

**The County Borough of Conwy (Various Roads Abergele)**  
**(Prohibition of Waiting) Order 2022**

On 18 February 2022 the Conwy County Borough Council made the above-named Order under Sections 1 and 2 of the Road Traffic Regulation Act 1984, the effect of which is to prohibit the waiting of vehicles at any time in the lengths of road specified in the Schedule 1 and designate the length of road specified in Schedule 2 as a disabled parking bay.

Exceptions are provided in the Order to permit waiting for the purposes of alighting, boarding, loading, unloading and works of maintenance, repair and the like. Exceptions are provided in the Order for vehicles displaying both a disabled person's badge and a disabled person's parking disc. A copy of the Order and plan, which will come into operation on the 1 March 2022 may be examined on the Council website.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any instrument made under it, has not been complied with in relation to the Order, you may, within six weeks from the date hereof apply to the High Court for this purpose.

<b>Pentre Mawr Access Road</b>	<b>South west side:</b> from its junction with Dundonald Ave for a distance of 20 metres in a westerly direction <b>North side:</b> from its junction with Dundonald Avenue for a distance of 12 metres in a westerly direction
<b>Maes Canol</b>	<b>North side;</b> from its junction with Dundonald Avenue for a distance of 230 metres in an easterly direction. <b>South side;</b> from its junction with Dundonald Avenue for a distance of 90 metres in an easterly direction. <b>South side;</b> from a point 17m west of its junction with Sydenham Ave to its junction with Ffordd Y Morfa
<b>Ffordd Y Morfa</b>	<b>East side;</b> from its junction with Maes Canol Road for a distance of 37 metres in a south-easterly direction. <b>West side;</b> <ol style="list-style-type: none"> <li>1. from a point 37 metres south east of its junction with Maes Canol for a distance of 130 metres</li> <li>2. from a point 12 metres north east of its junction with Faenol Avenue for a distance of 50 metres</li> </ol>
<b>Dundonald Ave</b>	<b>East side:</b> from a point 11 metres south of its junction with Maes Canol for a distance of 26metres in a north easterly direction

	<b>West Side:</b> from a point 16 metres south west of its junction with Pentre Mawr Access road for a distance of 30 metres in a north easterly direction
