**The County Borough of Conwy (St John's Park Penmaenmawr)**  
**(One-way Traffic) Order 2022**

The Conwy County Borough Council proposes to make an Order under Sections 1 & 2 of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit vehicular traffic proceeding in the length of road specified in Column 1 of the Schedule below from travelling in a direction other than that specified in Column 2.
