Nifer presennol y disgyblion yn yr ysgol yw 238. Capaciti disgyblion yr ysgol yw 200 a'r capaciti arfaethedig ar ôl gweithredu'r cynnig fydd 260.

Notice is hereby given in accordance with Section 41 & 43 of the School Standards and Organisation (Wales) Act 2013 and the School Organisation Code – Second Edition, that Conwy County Borough Council, having consulted such persons as required, propose:

- From 1 September 2020 to increase the number of pupils for whom Ysgol y Gogarth, Nant y Gamar Road, Llandudno, LL30 1YE can make provision from 200 to 260.

The current number of pupils at the School is 238. The pupil capacity of the School is 200 and the proposed capacity once the proposal is implemented will be 260.

Conwy County Borough Council undertook a period of consultation before deciding to publish this proposal. A Consultation Report containing a summary of the issues raised by consultees, the proposers' responses and the views of Estyn is available on the Conwy County Borough Council, Education Services website:
